Which projects have been submitted to the Italian Ministry of energy?

The 111MW project in Lombardia and the 97MW project in Puglia have been submitted to the Italian Ministry of Energy for approval. The 187MW project in Piemonte will be submitted for approval later this year.

How much energy will Italy need by 2033?

Terna (the Italian TSO) estimates in the last Adequacy Report for the Italian Electricity System that Italy will need around 27GW of energy storage capacity by 2033 to add a planned 120 GW+ of renewable generation to the Italian grid.

Where does energy come from in Italy?

Energy in Italy comes mostly from fossil fuels. Among the most used resources are petroleum (mostly used for the transport sector), natural gas (used for electric energy production and heating), coal and renewables. Italy has few energy resources, and most supplies are imported.

What is Italy's primary energy consumption?

Primary energy consumption is massively dominated by fossil fuels: 73.9% (coal: 5.4%; oil: 34.5%; natural gas: 34.0%); renewable energies cover only 20.5% of needs, and the electricity import balance provides the remaining 5.6%. Italian primary energy consumption per capita in 2019 was 103.4 GJ, 31% higher than the world average (79.1 GJ).
