This has a dramatic impact on private companies that produce the bulk share of renewable energy and Mexico"s economy as a whole. The U.S. National Renewable Energy Laboratory (NREL) estimates that this move increases overall power generation costs by 32-54 percent and results in an increase of 35 percent of power outages per year.

In October 2021, President Lopez-Obrador announced a new reform initiative which "[gives] the CFE its place" by giving CFE 54% of the market and maintaining the other 46% for private companies. The reform is part of the President's larger plan to move towards nationalization of the energy marketplace in Mexico and is a response to the 2014 Energy Reform package.

The government is set to review Public-Private Partnerships (PPPs) in the energy sector to establish what it calls "fairer conditions" for both public entities and private companies. Alicia ...
