Is Algeria transitioning to a new energy model?

However, the issue of energy transition became a priority for the Algerian government back in 2011. Algeria's transition to a new energy model was enshrined in the establishment of a renewable energy development program (PNER) as well as incentive measures. The PNER initially aimed at installing a renewable energy capacity of around 22 GW by 2030.

Is Algeria a reliable energy partner?

European Council president Charles Michel recently praised the north-African country as a "reliable" energy partner. Yet, while the EU plans to switch to renewable energies long-term, Algeria is torn between the need to diversify its economy and cut its reliance on energy exports, and the availability of hydrocarbon revenues.

Is Algeria a good country for electricity?

Algeria has the technical and financial capacity to meet the country's electricity needs, as well as the assets required for its energy transition. Significant efforts have been made to increase the production capacity, as evident in the development of the installed power generation capacity over the past decade.

What is Algeria doing to diversify its energy mix?

To diversify its energy mix dominated by gas and oil, Algeria aims to reach 15,000 MW of solar energy by 2035. The country has also signed a partnership with Germany whose objective is to produce, and eventually export green hydrogen via the pipelines connecting it to Europe.

How has Algeria's energy mix changed over the last 5 years?

Over the last 5 years, how has the energy mix changed, and what have been the key drivers? In 2018, Algeria's energy mix was composed of 1% liquid petroleum gas (LPG), 20% oil products and 79% gas. 1 Experts believe that the country will reach "peak oil" between 2035 and 2040.

Should the EU invest in solar power plants in Algeria?

Through the European Investment Bank (EIB) and the European Bank for Reconstruction and Development (EBRD), the EU should boost Algerian investment in thermal power plants, considering the price of the solar kilowatt-hour is lower than the price of energy production from fossil fuels.

The sudden drop in the price of oil, Algeria's main export, in 1985, when the barrel dropped from \$40 to less than \$10, caused a full-blown recession.
