Should lithium Argentina become a low-cost lithium producer?

Lithium Argentina should benefit, as there should be more than enough demand for the company's resources to enter production and expand capacity over time. Lithium Argentina will become a low-cost lithium producer generating profitability regardless of lithium prices.

Will lithium demand increase in Argentina?

As electric vehicle adoption increases, we expect durable double-digit annual growth for lithium demand. Lithium Argentina should benefit, as there should be more than enough demand for the company's resources to enter production and expand capacity over time.

Is Rio Tinto drilling a lithium mine in Argentina?

Under the permit approval from the mining and energy secretariat in Argentina's northwestern Salta province, the company will launch a drilling program to evaluate lithium concentrations in area salt flats, part of the Rincon Oeste project. It lies next to major miner Rio Tinto's similar lithium development Proyecto Rincon.

How many metric tons will lithium Argentina produce a year?

Longer-term, we estimate the project will grow its annual capacity to 120,000 metric tons. As Lithium Argentina has a 44.8% ownership in the project, this amounts to nearly 54,000 metric tons for Lithium Argentina's share. Additionally, we assume that the Pastos Grandes project will enter production early in the next decade.

Traditionally, there were two ways to produce lithium; from hard rock minerals or from ultra-salty brines. In 2022 approximately 60% of global lithium production came from hard rock deposits, primarily located in Australia, with the remainder (30% evaporation pond and 10% DLE) coming from brine resources mainly from Chile and Argentina [15].
