Aura Power has secured planning permission for a solar farm between Murton and South Hetton, with a capacity of up to 49.9MW (Megawatts). The solar farm will be built without subsidy and would generate enough clean electricity to power the equivalent of over 17,000 homes, saving around 15,203 tonnes of CO2 from entering the atmosphere each year.

As such, it would not result in any emissions during operation. It would act as a "balancing service" for the grid in
