Who owns Azule energy Angola?

ii. Azule Energy Angola (Block 18) B.V Azule Energy is a new standalone integrated energy company created as an incorporated joint venture between BP Exploration Operating Company Limited("bp") and Eni International B.V. ("Eni"), with bp and Eni each holding a 50% share to combine the assets and workforces of bp and Eni in Angola.

Who is Angola's largest oil & gas producer?

Azule Energyis now Angola's largest independent equity producer of oil and gas,holding 2 billion barrels equivalent of net resources and growing to about 250,000 barrels equivalent a day (boe/d) of equity oil and gas production over the next 5 years.

What are the major energy projects in Angola?

These include the Agogo Full Field and PAJ oil projectsin Blocks 15/06 and 31 respectively, and the New Gas Consortium (NGC), the first non-associated gas project in the country, which will support the energy needs of Angola's growing economy and strengthen its role as a global LNG exporter.

How much energy is produced in Angola in 2021?

In 2021 bp's total production in Angola was approximately 100,000 boe/d. Eni's total production in Angola was approximately 100,000 boe/d. Both bp's and Eni's equity share of Azule Energy's production is expected to be approximately 100,000 boe/d.
