Will Belgium's energy mix be reliant on imports in 2035-2050?

Belgium's existing generation facilities and already-approved investments can provide only half of what is needed in the long term. Therefore, new governments will soon have to consider the desired energy mix for the period 2035-2050 and how reliant the country is willing to be on imports.

How will Belgium's energy island contribute to the green energy transition?

The energy island will play an important role in the green energy transition for both Belgium and the broader European Union, which is why it receives substantial EU support. However, due to the rising demand for electricity, this will no longer be sufficient in 10 years' time. If policy remains unchanged, we will see Belgium's dependence on electricity imports steadily increase, from 50-60 TWh in 2036 to 70-90 TWh in 2050.
