However, the highest political authority in the country is the High Representative for Bosnia and Herzegovina, the chief executive officer for the international civilian presence in the country and is selected by the European Union.

The Parliamentary Assembly is the lawmaking bodyin Bosnia and Herzegovina. It consists of two houses: the House of Peoples and the House of Representatives.

Who owns the railways in Bosnia & Herzegovina?

Corruption in Bosnia and Herzegovina is a severe problem. The Armed Forces of Bosnia and Herzegovina (OSBiH) were unified into a single entity in 2005, with the merger of the Army of the Federation of Bosnia and Herzegovina and the Army of Republika Srpska, which had defended their respective regions.
