Both Brookfield Renewable and Neoen have significant portfolios of renewables and energy storage assets. Brookfield Renewable has close to 34GW of operational capacity and a claimed 157GW development pipeline including a recent government tender win for a combined 400MW of battery energy storage system (BESS) projects in Ontario, Canada ...
