#### How many locker rooms are ADA compliant?

In accordance with Section 225.2 of the 2010 ADA Standard, for locker rooms with 1 to 200 lockers, at least five percent but no fewer than one must be accessible, and in facilities with more than 201 lockers, ten lockers plus two percent of the total number of units over two hundred must be accessible. So what does "accessible" mean?

#### Are Z-tier lockers ADA compliant?

Z-Tier lockers allow for wheelchair accessibility and can be designed to ensure Locker ADA complianceand barrier-free mobility. They are made to meet the range and height requirements described in the 2010 ADA Standard. Benches can be added that maintain ADA compliance and wheelchair accessibility.
