How much does Crius energy pay per unit?

Crius Energy's unitholders will receive CAD 8.8 (USD 6.75/EUR 6) per unit this week. In addition, holders of record on March 26, 2019 are also getting a distribution of CAD 0.209 per unit, a previously declared by Crius. The company is expected to be wound-up following the redemption of the trust units on July 18.

What is Crius energy cash consideration?

The cash consideration of C\$7.57 per unit represents around 38% premium to Crius Energy's each unit price of C\$5.48 as of market close on 6 February 2019. In addition to the purchase price, Crius Energy unitholders will also get an earlier-declared amount of C\$0.209 per unit for total consideration of C\$7.779 per unit in the first quarter of 2019.
