Does the US import solar panels?

U.S. solar panel shipmentsinclude imports,exports,and domestically produced and shipped panels. The difference between importsand shipments is usually because of the lag time between when panels are imported and when they're installed.

Which countries import solar panels?

Back to normal? US solar panel imports in the first quarter of 2023 totaled 850,157 metric tons, up from 672,863 metric tons in the fourth quarter of 2022. Vietnam alone accounted for 30.4% of shipments to the US, followed by Thailand, Malaysia and Cambodia.

Are US solar panel imports rising?

US solar panel imports may also be risingas US Customs and Border Protection releases modules detained as part of its enforcement of the Uyghur Forced Labor Prevention Act,a 2021 US law that banned imports linked to China's Xinjiang region unless the importer can prove that goods were made in the absence of forced labor.

How many solar modules were imported in 2023?

U.S. PV Imports According to U.S. Census data,55.6 GW dcof modules and 3.7 GW dc of cells were imported in 2023,an increase of 87% y/y and 46% y/y,respectively. In Q1 2024,PV module imports held relatively steady for the third straight quarter at 15.2 GW dc.

What will the US government do if imported solar panels exceed quota?

The Administration will closely monitor the level of imported solar cells used to manufacture panels in the U.S. and will work to raise the quota by 7.5-gigawattsif imports approach the current quota level,to ensure domestic module manufacturing continues to grow while manufacturers scale production throughout the supply chain.
