Grid Resilience Formula Grant: On July 31,2023,DOE announced that Puerto Rico will receive over \$7.4 millionthrough the Grid Resilience State and Tribal Formula Grants as part of President Biden's Investing in America agenda.

When did Luma take over Puerto Rico's electric grid?

On the state of ongoing challenges: "LUMA took over as the transmission and distribution operator of Puerto Rico's electric grid in June 2021, only four years following the devastating impacts of Hurricane Maria.

Does Puerto Rico need a grid modernization?

In September 2022, Hurricane Fiona again knocked out 100% of the grid for as long as four weeks in parts of Puerto Rico, highlighting the continuing need for grid modernization on the island.

The island is required by the 2019 Puerto Rico Energy Policy Act to reach 40% of its renewable-sources energy goal by 2025 -- a seemingly impossible goal. For example, the island's government recently launched a campaign to provide low-income households with solar panels, but the initiative has made little progress.

Puerto Rico"s Energy Transition. Puerto Rico committed to meeting its electricity needs with 100% renewable energy by 2050, as established in Puerto Rico Energy Public Policy Act (Act 17). To meet these goals and support widespread end-use electrification, Puerto Rico is exploring renewable energy and other generation technologies for energy storage, distributed ...
