

What are energy-related products (ERP) and energy-using products (EuP)?

Energy-related products (ErP) are products that use energy, or that do not use energy but have an indirect impact on energy consumption, such as water using devices, building insulation products, windows, etc. Compared to ErP, energy-using products (EuP) are products which are dependent on energy input (electricity etc.).

How is energy used in Burkina Faso?

Total energy supply (TES) includes all the energy produced in or imported to a country, minus that which is exported or stored. It represents all the energy required to supply end users in the country.

What are the different types of energy transformation in Burkina Faso?

One of the most important types of transformation for the energy system is the refining of crude oil into oil products, such as the fuels that power automobiles, ships and planes. No data for Burkina Faso for 2021. Another important form of transformation is the generation of electricity.

How has Burkina Faso changed over the years?

Burkina Faso has made remarkable progress in recent years, with an increase in installed capacity from 324.6 megawatts (MW) in 2017 to 410 megawatts in 2019. The share of renewable energy also surged from 9.4% in 2015 to 18.36% in 2019.

How long does a power outage last in Burkina Faso?

The average power outage time was 233 hours in 2018, compared with 172 hours in 2017. In addition, the cost of energy remains high for households and businesses, at XOF 75 per KWh of high-voltage electricity in 2019. No on-grid IPPs operating in Burkina Faso

What is the new ErP-directive?

The new ErP-Directive covers products under the old EuP Directive as well as products that are energy-related and do not directly use energy such as water-saving taps and showerheads. With this directive, the European Union regulator laid the groundwork for specific implementing measures affecting a broad range of EuP and ErP.
