Is oil a source of economic security for Falkland Islanders?

Despite the difficulties, Falkland Islanders have come to regard oil as a potential source of economic security. Oil was not a key issue for the residents of the islands before the Falklands War. During Anglo-Argentine negotiations in 1981, two Islanders, accompanied by FCO minister Nicolas Ridley, met Argentine officials in New York.

## Who owns Falklands oil fields?

Rockhopper Petroleum,a tiny British oil and gas exploration company founded in 2004 with a cash balance of only US\$17 million in 2019,now holds by far the biggest share of Falklands oil fields (Rockhopper Exploration PLC,2019).

Is oil a factor in British policy towards the Falkland Islands?

This article demonstrates that oil has been a factor in British policy towards the Falkland Islands since the 1970s. It charts the changing perspectives of oil companies and considers how these have informed British policy.

Why did the Falkland Islands Committee lobby for oil exploration?

The UK-based Falkland Islands Committee,however,did lobby in favour of oil exploration. This was partly because it had links with the Falkland Islands Company and other private firms, which would benefit from increased economic activity in and around the islands.

How much does oil & gas contribute to the Falklands Islands GDP?

Oil and gas exploration, along with other mining and quarrying activities, contributed only 0.8% to the Falklands Islands GDP in 2007; this soared to 20% during the 2015 oil drilling campaign but fell back to 0.4% by 2018 (FIG, 2014, 2020).

When did oil companies start exploring the Falkland Islands?

Oil companies began asking the FCO for licences to explore the waters around the Falkland Islands in the late 1960s. The British government commissioned a geological survey of the area in 1971, which found that the prospects were 'sufficiently promising to encourage further commercial exploration' (Griffiths et al.,1975).
