

Are there renewables in the Faroe Islands?

"In the Faroe Islands, we are blessed with renewables: we have wind, hydro and some sun in the summer; we also have tidal and wave power where we can see great potential," says Nielsen. Since announcing its green vision in 2014, SEV has already done a lot to increase the share of renewables in its energy mix.

Why is Sev the main power supplier in the Faroe Islands?

SEV is the main power supplier in the Faroe Islands. We operate on 17 of the 18 islands that constitute the Faroe Islands. Isolated in the North Atlantic Ocean, the Faroe Islands need to be self-sufficient in terms of electricity generation as the Faroese electrical grid is not interconnected to neighbouring countries.

Are the Faroe Islands a sustainable country?

Did you know that the Faroe Islands is one of the world's leading nations in producing sustainable electricity with over 50% of the nation's electricity deriving from renewable energy sources? There is no shortage of renewable power in the Faroe Islands, due to the ocean currents and tides of the Northeast Atlantic and an abundance of strong wind.

Does Sev have a monopoly on the Faroe Islands?

Although SEV does not have the electricity distribution monopoly by law, it is the only company who supplies electricity on the Faroe Islands. SEV has been setting a target of the islands being 100% supplied by renewable electricity by 2030. [6]

How does a virtual power plant work in the Faroe Islands?

In November 2012 the Faroe Islands became the first place in the world where a virtual power plant (Power Hub) was used to recreate balance in an island power system by decoupling large industrial units in less than a second from the main power system, thereby avoiding blackouts.

The archipelago is composed of 18 islands covering 1,399 km²; (545.3 sq mi) and is 113 km (70 mi) long and 75 km (47 mi) wide. 17 islands are inhabited, leaving just one uninhabited island, the smallest island, Lítla Dímum. There are a lot of smaller islets and skerries around the Faroe Islands. Including the 18 islands, there are 779 islands, islets and skerries in the Faroe Islands.

The Faroe Islands have bilateral free trade agreements with the EU, Iceland, Norway, Switzerland, and Turkey. For the first time in 8 years, the Faroe Islands managed to generate a public budget surplus in 2016, a trend which continued in 2017.
