#### Government leases rooftop solar power

Can rooftop solar panels be installed on homes & businesses?

The government has announced a change in planning rules that will enable rooftop solar panels to be installed on homes and businesses through permitted development rights. This means that homeowners and businesses won't need to go through the full planning process.

Can you get free solar panels on a roof?

Companies offered to pay to lease your roof from you for 20-25 years and,in exchange,would install and maintain solar PV panels on it. You didn't have to pay upfront for the panels,and would also benefit from the free electricity produced by the system. But there are very few free solar panel schemes available now.

Do you need a lease agreement for solar panels?

If you're moving into a property with solar panels installed as part of a 'rent-a-roof' scheme, there should be a signed agreement between the homeowner and the rent-a-roof company. This could be a lease agreement, where the homeowner agrees to rent out their roof space to the company which installed the solar panels.

Can you install solar panels on your roof?

Homes and businesses will be able to install rooftop solar panels more easily,under new rules announced today. Changes to permitted development rights rules will mean more homeowners and businesses will be able to install solar panels on their roofs without going through the planning system.

Is rooftop solar a good investment?
