What is Finland's energy subsidy scheme?

The aim of the subsidy scheme is to promote energy investment and energy infrastructure projects that are in line with the Sustainable Growth Programme for Finlandand that reduce greenhouse gas emissions in Finland and support the country's 2035 carbon neutrality target.

What is Finland's energy investment aid plan?

On 4 October 2022, the Ministry of Economic Affairs and Employment made the first energy investment aid decisions under Finland's Recovery and Resilience Planto promote clean energy solutions. Aid was granted to six projects totalling EUR 99.8 million.

Can Business Finland grant Energy Aid?

Business Finland may grant Energy Aidto projects with investment costs of at least EUR 10,000 (energy efficiency investments) or EUR 30,000 (other energy investments, such as renewable energy or utilizing waste heat as district heat). There is no upper limit for the size of the project.

How much energy does a solar plant produce in Finland?

Supported by RENEWFM with EUR 9.9 million, the expected output of the plant is 67,6 GWh per year and will contribute to decrease approximately 3650 tons of CO 2 emissions annually in Finland. Poytya Solar: a 40,16 MWp Solar PV production site, located in Pö ytyä, in the Southwest of Finland.

How does the Sustainable Growth Programme work in Finland?

The Ministry of Economic Affairs and Employment and Business Finland will announce the first call for applications in the next few days. Is solar PV a viable alternative to wind power in Finland?

However, solar PV is currently in Finland the second least cost option for new electric power generation after wind power.
