### Does Greece have a good environmental performance?

The report reviews Greece's environmental performance since 2009. The OECD is grateful to the examining countries: Israel and Portugal. The EPR provides 49 recommendations, approved by the OECD Working Party on Environmental Performance (WPEP) on 26 February 2020.

Does Greece have an environmental dimension?

The priority given to SDGs 6, 7, 11, 12, 13, 14 and 15 with an environmental dimension is based on the notion that Greece's natural environment constitutes not only the identity of the country but is also a key asset for development.

### What is the Environmental Performance Review of Greece?

This is the third Environmental Performance Review of Greece. It evaluates progress towards sustainable development and green growth, with special features on climate change mitigation and adaptation, and biodiversity conservation and sustainable use. Greece underwent extensive reforms to cope with a deep recession.

#### How can Greece improve the environment?

They aim to help Greece advance towards green growth and sustainable development; implement ambitious decarbonisation policies; strengthen environmental governance; and better mainstream biodiversity into agriculture, fi sheries, transport and tourism. Particular emphasis is placed on climate change mitigation and adaptation and on biodiversity.

#### What are the SDGs of Greece?

Greece prioritises actions towards SDGs 6,7,11,12,13,14 and 15with an environmental dimension As Greece is a maritime nation and a coastal state,shipping,fishing,development of offshore energy sources,port and transportation facilities,recreation and tourism are vital economic activities (SDG 14).

### Does Greece have a plan to reduce air pollution?

Air pollution has declined but Greece lacks a programme to reduce significant negative health effects. In general, improved monitoring and information will help strengthen environmental management. In a welcome move, Greece adopted a National Circular Economy Strategy and introduced a tax on single-use plastic bags.
