The history of Western Sahara can be traced back to the times of Carthaginian explorer Hanno the Navigator in the 5th century BC. Though few historical records are left from that period, Western Sahara''s modern history has its roots linked to some nomadic groups (living under Berber tribal rule and in contact with the Roman Empire) such as the Sanhaja group, and the ...

The term Sahrawi...is often used to mean "indigenous Western Saharan," although this equivalent is not accurate deed, it is sufficient on most accounts that an "ethnic" Sahrawi only has to claim descent from one of the recognized major or minor social groupings--"tribes" or "confederations"--in or overlapping the former Spanish Sahara....
