### What is a PV installation agreement?

The Installation Agreement is a lump-sum agreementbetween the project company, as owner of the project, and the installation contractor, the contractor that will be responsible for installing the PV system, providing the balance of plant and commissioning the plant.

### How are open solar contracts drafted?

The Open Solar Contracts are drafted on the assumption that the buyer is a national or local government-owned or government-controlled utility (but this also can be extended to private buyers authorised by the government). Furthermore, the oftake is assumed to be guaranteed in some form.

### What is a solar power purchase agreement (PPA)?

A Solar Power Purchase Agreement (PPA) is a long-term contractual agreementin which a solar developer installs, operates, and maintains a solar energy system on a customer's property or other designated location. In exchange, the customer, known as the host, receives discounted energy prices below the utility rate.

#### What is a solar PPA template?

This solar PPA template document was developed by a group of solar developers, law firms, and other interested parties in the solar energy space. It represents a consensus around one possible approach to solar finance, with a particular emphasis on access to the broader capital markets.
