

# How to write the export declaration of photovoltaic bracket

When should I make an export declaration?

You or your representative must submit an export declaration and get clearance from customs before the goods are allowed to leave the UK. When you should make your declaration depends on the last mode of transport you use to move the goods. You must make a declaration at least one hour before your departure when using road or inland waters.

What information should be included in a UK Export declaration?

The goods must be taken to the port or UK border location named in the export declaration. Customs staff might check the goods before allowing them to cross the UK border. Don't include personal or financial information like your National Insurance number or credit card details.

What is an export declaration form?

An export declaration form is a mandatory document that provides comprehensive information about the goods intended for export. It includes: Customs authorities use export declaration forms to monitor and manage the flow of exports, ensuring compliance with national and international trade regulations.
