How much money did Hungarian government spend on solar panels?

The original HUF 75.8 billion budget was increased by HUF 30 billion in July. The Hungarian Ministry of Energy has said that more than 20,000 households have applied for the Napenergia Plusz Program, a grant scheme for installing residential solar panels and storage systems.

How much does PV cost in Hungary?

The Hungarian government says 20,000 households have signed up for its PV subsidies scheme, which offers up to HUF 5 million (\$14,125) per home installation. The original HUF 75.8 billion budget was increased by HUF 30 billion in July.

How many solar panels are installed in Hungary?

Hungary reached a cumulative installed PV capacity of more than 700 MW last year, according to provisional numbers given to pv magazine by Ádám Szolnoki, president of the Hungarian Photovoltaic Industry Association. Szolnoki said 2018 was a record year for solar deployment in the country with 410 MW of new capacity.

In 2017, the installed grid-connected solar PV system capacity in Hungary was about 90 MWp; this raised the cumulative installed capacity to 380 MWp by the end of 2017 [7] 2018 the installed capacity of solar PV was 410 MWp [8] Thereby, increasing the cumulative installed PV capacity to about 790 MWp in 2018 [9].
