Does India have a battery production capacity?

Similarly,India does not have sizable production capacityfor battery cells (i.e.,less than 1 percent of global capacity),but Indian companies are building battery cell production facilities,with LFP chemistries estimated to represent 70 percent of India's future battery production.

Could India export lead-acid batteries to South Korea?

Similarly,India,which already exports lead-acid batteries to many countries,could export LFP battery cells and battery packs for two-wheeled and three-wheeled vehicles to countries in South Asia and Southeast Asia. It could continue to export black mass for recycling to South Korea too.
