Who have invested in Intercontinental Energy?

InterContinental Energy received USD 115 million in equity investment from GIC, a leading global institutional investor, and Hy24, the world's largest clean hydrogen pureplay investor.

Who owns Intercontinental Energy?

In April, the Government of Singapore Investment Corporation (GIC) became the strategic investor of InterContinental Energy. In late 2022, bp took over the operatorship of AREH and the project was renamed the Australian Renewable Energy Hub. In January, Shell joined the GEO consortium as the lead operating partner.

Does Intercontinental Energy Invest in green hydrogen?

Yes, we are active in the entire value chain, creating new opportunities for InterContinental Energy and its stakeholders. Green hydrogen is an emerging sector with market sizing potential forecasted to reach between 450 and 600 million tons per annum (MTPA) by 2050. InterContinental Energy's portfolio of projects is among the largest in the world.

What is the role of coal in Venezuela's energy mix?

In comparison to oil and natural gas, coal plays a minor role in Venezuela's energy mix, accounting for 0.2% of total energy production and 0.1% of total energy consumption. Venezuela's coal industry has faced challenges such as outdated infrastructure and limited investment, which has affected production.
