Can I install solar panels if I don't meet building regulations?

Can solar panels be built without permission?

The exceptions to this rule are typically flats, listed buildings, homes in conservation areas, and ground-mounted installations. What are the building regulations for solar panels?

Do solar panels need planning permission?

It is true that the majority of solar PV installations will be classed as a PD. However, there are instances where you will need to seek planning permission from your local authority. This is the case if your solar panels: If you live in Scotland, there are a few additional rules that require planning permission.

When did solar panels become a building regulation?

In 2005, household electrical work was absorbed into the UK government's official Building Regulations. A year later, the Climate Change and Sustainable Energy Act 2006 brought microgeneration systems like solar panels under the umbrella of the Building Regulations.
