Does Kosovo\* have a reporting obligation?

Kosovo\*has initiated reporting on national systems for policies and measures and projections, but has yet to submit a report in Reportnet. Reporting obligations have been transposed in the legislation. Kosovo\*has nominated lead reporters for the Governance Reg-ulation reporting activities.

How does Albania - Kosovo balancing work?
