What are Libya's energy & energy agreements?

These agreements aim to develop solar projects supplying electricity to the Libyan people and to invest in projects reducing gas flaring in oil fields in order to supply gas to power plants as well as to contribute to the national goal of restoring the country's oil production to 2 million barrels per day and supplying world markets.

How much solar power does Libya have?

In terms of solar power potential, Libya boasts approximately 3,200 annual brightness hoursand an average radiation of 6 KWh per m2 per day. For reference, each km2 of desert in the country receives solar energy equivalent to 1.5 million barrels of crude oil annually.
