Who is Lumio solar?

Lumio started in the solar industry in 2021 after acquiring four solar companies -- Atlantic Key Energy, Lift Energy Solar, Smart Energy Today and DECA -- and merging them with Unyte Homes, a home technology company. The company has a limited service area, operating in just 16 states at the time of writing.

When did Lumio file for bankruptcy?

Lumio filed for Chapter 11 bankruptcy in September. Lumio's markets. Florida-based residential solar and energy efficiency installer Zeo Energy has acquired Lumio Holdings, Inc. On September 3, 2024, residential solar installer Lumio filed for Chapter 11 bankruptcy. The sale of Lumio to Zeo Energy closed on November 1, 2024.

How much do Lumio solar panels cost?

Lumio does not provide information about the cost of its solar panels. However, you can complete an online form to receive a custom quote based on your home's energy usage and local climate. According to Energy.gov, the average cost to install a typical six-kilowatt (kW) solar panel system with a battery ranges from \$25,000 to \$35,000.

Is Lumio a good solar company?

Lumio provides a variety of solar products and services, but it doesn't do everything. The company doesn't sell or install solar roofs. Also, Lumio doesn't offer a live chat or other potentially helpful online resources, such as an FAQ page or community forum, on its website. Lumio has an easy-to-use website, with large fonts and simple structures.

Where does Lumio live?

Our founders started out as local small business owners and employed their friends and family--literally walking the streets from home to home to share the benefits of residential solar.

What happened to Lumio energy?

For instance, Atlantic Key Energy has 4.1 stars out of 5.0 from more than 700 Google reviews. In early September 2024, Lumio filed for Chapter 11 bankruptcy and was sold to its loan lender, White Oak Global Advisors LLC. Once the sale is complete, the company plans to resume its operations.
