

## Mauritius greenyellow solar

GreenYellow secures financing for new solar project in Mauritius Jan 25, 2023 10:57 AM ET French clean energy solutions provider GreenYellow revealed on Tuesday it has actually closed an MUR-350-million (USD 7.9 m/EUR 7.2 m) funding deal with the Mauritius Commercial Bank Ltd for a new photovoltaic (PV) project in the island country.

France's GreenYellow Oc&#233;an Indien, part of the Casino Group, has signed an agreement with Mauritius' Central Electricity Board (CEB) to build a 13.86MW plant at Arsenal, in the north of the island. The project, which is expected to generate more than 22GWh, is the second solar PV plant to be developed by GreenYellow for CEB. The company brought online the 16.3MW Solitude ...

The solar facility is expected to enter commercial operation by 2023 and will help in diversifying Mauritius' energy mix. According to GreenYellow, the solar PV plant will supply 4,500 households with clean electricity and reduce emissions by nearly 13,000 tons of CO2 equivalent per year.

Paris-based provider of solar power solutions, GreenYellow, announced it has concluded a transaction worth Rs 350M (7.5M EUR) with Mauritius Commercial Bank (MCB) to finance a solar photovoltaic power plant Arsenal, Mauritius. Description The project is developed and owned by GreenYellow. Queen Victoria Solar PV Park is a ground-mounted solar project. The project generates 22,885MWh electricity thereby offsetting 22,107t of carbon dioxide emissions (CO2) a year.

Solitude Solar PV Park is a 16.344MW solar PV power project. It is located in Pamplemousses, Mauritius. According to GlobalData, who tracks and profiles over 170,000 power plants worldwide, the project is currently active. It has been developed in a single phase. Post completion of construction, the project got commissioned in February 2019.
