There are numerous national and international bodies that set standards for photovoltaics. There are standards for nearly every stage of the PV life cycle, including materials and processes used in the production of PV panels, testing methodologies, performance standards, and design and installation guidelines.

What are the NFPA requirements for solar panels?

The electrical portion of solar PV systems shall be designed and installed in accordance with NFPA 70. R324.3.1 Equipment listings. Photovoltaic panels and modules shall be listed and labeled in accordance with UL 1703 or with both UL 61730-1 and UL 61730-2. Inverters shall be listed and labeled in accordance with UL 1741.

What is NFPA 70 for solar energy systems?

2015 IRC, Section 324 Solar Energy Systems R324.3 Photovoltaic systems. Photovoltaic systems shall be designed and installed in accordance with Sections R324.3.1 through R324.7.1 and the manufacturers installation instructions. The electrical portion of solar PV systems shall be designed and installed in accordance with NFPA 70.
