What is a Nordex gamma wind turbine?

As of 2013, the third generation of Nordex wind turbines included two platforms, rated at 2.4 and 3.3 MW. In Europe, Africa and North America Nordex manufactures and sells the Gamma series, a product family comprising the N90/2500, the N100/2500 and the N117/2400. The N90/2500 is a turbine being developed for strong winds.

Who makes Nordex turbine boosters?

In 1995 Nordex was the first company to mass-produce a 1 MW turbine booster. The company's wind Babcock-Borsighas been fully implanted into Nordex on October 1, 2001. Nordex began also producing the turbines of the manufacturer's wind, which had previously gone bankrupt.
