Does ABB own Hitachi energy?

Swiss technology company ABB has decided to sell its remaining stake in the Hitachi Energy joint venture (JV) to Hitachi. Hitachi Energy is a JV company formed from ABB's Power Grids business in 2020.

What does ABB's Power Grids business mean for Hitachi?

ABB's power grids business will strengthen Hitachi as a global leader in energy infrastructure and Hitachi will strengthen the position of ABB's power grids business as a global leader. Revenues of the business stood at \$10bn in the fiscal year 2017.

What happened to Hitachi ABB power grids?

Coinciding with its first-year anniversary, the global technology and market leader announces that it will be changing its name and corporate brand from October 2021. Hitachi ABB Power Grids today announced that it will be evolving to become Hitachi Energy from October 2021.

Where is Hitachi ABB power grids headquartered?

Operating as Hitachi ABB Power Grids, the venture will be headquartered in Switzerland. With the completion of the divestment, ABB intends to focus on key market trends. It says these include the electrification of transport and industry, automated manufacturing, digital solutions, and increased sustainable productivity.

Who owns Hitachi energy?

Hitachi Energy is a JV company formed from ABB's Power Grids business in 2020. ABB owned a 19.9% stake in the JV, while Hitachi held the remaining 80.1% stake. By exercising its call option, Hitachi will now acquire the stake held by ABB. The call option was agreed between the two companies in December 2018 and is valued at around \$1.68bn.

What is the future of ABB's Power Grids business?

"The combination of ABB's power grids business with Hitachi positions power grids business for a successful long-term future as a globally leading infrastructure business." Additionally, the Japanese firm intends to create a new energy platform, which will connect various segments such as mobility, life, and industry.
