Who is one Energy Enterprises?

One Energy Enterprises, doing business as One Energy, is a private American industrial power company headquartered in Findlay, Ohio, that constructs, owns and operates industrial power systems and infrastructure.

Who owns Senegal's power?

Since then, One Energy has continued to develop projects consisting of typically 1-3 wind turbines (each 1.5 MW) of on-site wind energy for industrial energy users.
