How do I register a photovoltaic inverter warranty?

1.6. The "Registration Form" is the Photovoltaic Inverter Warranty Registration Form as set forth in SUNGROW's website. The Registration Form must be completed and returned to SUNGROW. 1.7. "Service" means Actions in Item 2.1 in response to a claim. 1.8. "Site" means the location of End-user's Product that is covered under this Warranty. 1.9.

How long does JA Solar warranty last?

JA Solar warrants that the MODULES together with the factory-assembled DC connectors and cables are free from any defects in materials and workmanship under normal application, usage, installation and service conditions for a period of one hundred and forty four (144) months from the Warranty Commencement Date.

What are the extended warranty options for PV inverters?

Extended warranty options may be available to purchase for specific product range up to a total period of 25 years. 3.5. The Extended Warranty Contract must be taken out for all the inverters making up the PV plant; it cannot be taken out for a partial number of units. 3.6.

What is a limited peak power warranty?

Limited Peak Power Warranty- Limited Remedy standing at 83% of the Nominal Power at the end of the 30-year warranty period.

What if Trina Solar fails to pay a warranty claim?

Trina Solar must inform the Buyer about the non-payment and provide the name and the full address of the Direct Customer which has failed to pay the modules. In case that Trina Solar can reject the claim under this warranty based on this provision, the Buyer can deposit the amount not paid in order to trigger the warranty claims;

Does the limited product warranty cover glass breakage?

Applicable modules are set forth above in a) and b). will conform to the specifications and the drawings applicable thereto. This Limited Product Warranty covers glass breakage provided that there was no external cause of breakage (i.e. only breakage caused by the glass itself or the module is covered).
