How much money has been seized from a fraudulent solar panel scheme?

Two men who scammed millions of pounds from 760 vulnerable victims in a fraudulent solar panel scheme have today been ordered to pay confiscation totalling £413,206.10.

Did a company defraud solar panel owners?

A company which defrauded solar panel owners by selling them goods and services they did not need has been ordered to pay back its victims hundreds of thousands of pounds.

Are solar panels a scam?

One of the first signs of a potential scam is unsolicited approaches or door-to-door sales. A reputable solar panel company does not typically use these tactics and instead is more likely to rely on referrals or marketing campaigns. As we mentioned before, another red flag is excessive discounts or too-good-to-be-true offers.

How many people have been sentenced for solar panel fraud?

The 6 offenders were sentenced by His Honour Judge Warnock: Six men have been sentenced for a total of just over 30 years for their part in a £17 million solar panel fraud scheme.

Are 'fake' solar companies a scam?

Beware of any company asking you to make a big deposit before they have completed their installation. This is one of the most common ways 'fake' solar companies have targeted consumers - whereby they take a hefty deposit and then never turn up to carry out the installation. This is common solar scam.

Do you have a problem with your solar panel?
