There are currently three government grantsavailable to help with the upfront costs of solar panel installation: ECO4: Funding for energy-efficient retrofits to fuel-poor households,or ones with occupants on certain benefits. Each grant has different eligibility criteria, as well as the benefits they provide.

#### Can I get funding for a solar PV system?
