Who is pzem energy company?

PZEM Energy Company B.V is a subsidiary of EP NL, which, in its turn is a subsidiary of the EPH Group. EP NL is a key player in the Dutch energy market with installed capacity of 2.6 GW and a 1.5 GW portfolio of power purchase agreement. We focus on electricity generation, trading and the supply of energy and solutions for businesses.

Who owns Zeh & pzem energy company?

ZEH is a public limited company, with the Province of Zeeland owning half of the shares and the rest almost entirely owned by the various municipalities in Zeeland. PZEM Energy Company B.V is a subsidiary of EP NL, which, in its turn is a subsidiary of the EPH Group.

Will pzem provide electricity to NS?

On Wednesday, September 6th, it was announced that PZEM, in combination with Shell, will provide NS with the supply of electricity for train operations starting from January 1st 2025. NS, on behalf of the rail sector (under the name of cooperative VIVENS and CIEBR), invited the tender.

What happened to Zeeuwse energy houdstermaatschappij?

Today, Wednesday, January 25 2023, Zeeuwse Energie Houdstermaatschappij N.V. (ZEH N.V), formerly known as PZEM N.V, sold and transferred its interests in PZEM Energy Company B.V (PZEM) and PZEM Pipe B.V. (PZEM Pipe) to EP Netherlands B.V. This includes the interests that PZEM holds in Sloe Centrale Holding B.V. (50%).
