## Solar power generation loan fraud

Are people deceived by solar financing companies?

We don't want people deceived, though," says Adam Welle, a lawyer with the Minnesota Attorney General's Office who is pursuing a case against solar financing companies. Beyond the industry's reputation, real people - many of them already financially vulnerable - have been hurt.

Why is Minnesota suing a solar loan company?

Minnesota is suing firms who finance solar power systems for homes. The case alleges that four lending companies deceived customers with hidden,upfront fees in exchange for lower interest rates. "It's misleading people about the price of the system and misleading people about the price of financing," says Assistant Attorney General Welle.

Are solar systems a cost-saving misrepresentation?

Costs and savings misrepresentations,in particular, have typically spurred the ire of state AGs when solar companies exaggerate their systems' potential to save consumers money, despite financing that may end up costing the consumer more.
