

Solar power integration St Kitts and Nevis

Swiss energy storage company Leclanché has broken ground on a US\$70 million solar and storage microgrid project in St Kitts and Nevis. The system will include a 35.7MW solar farm and a 14.8MW ...

Perhaps one of the most innovative aspects of this project is the integration of solar power. The construction team has begun installing the solar farm that will provide clean, renewable energy to power the desalination process.

Construction has begun on a solar-plus-storage project on the Caribbean island of St. Kitts & Nevis, backed by Leclanché, Solrid and MPC Energy Solutions. The launch of ...

Leclanche's Green Power Plant project on the island of Saint Kitts will integrate a 35.7-MWp solar PV farm and a 45-MWh battery energy storage system (BESS) to deliver 18.2 MW of baseload power. The green energy outfit, also known as MPCES, has acquired a 40% stake in the project's holding company, in which Leclanche owns 60%, it said.

Once online, the solar-plus-storage system will operate under a 20-year power purchase agreement (PPA) with the state-owned St. Kitts Electric Company (SKELEC), charging a flat rate for the entire period.
