Installation subsidies: The Spanish government offers aid for the installation of photovoltaic systems, both for self-consumption and for the production of solar energy for the grid. This aid can cover up to 50 % of the cost of the installation.

How much does a solar system cost in Spain?

Subsidies based on these funds can be applied for until 31 December 2023. Depending on the type of installation and the power of the system, these are the established amounts for a single-family home in Spain: Subsidies of EUR600 per kWp for installations with a capacity of less than 10 kWp (most common) and EUR490 on the battery.
