Does Spain have solar energy?

Spain is one of Europe's largest solar photovoltaic (PV) energy producers. In 2021, solar accounted for 16% of Spain's installed capacity and 8% of the country's power generation as a whole. And solar energy in Spain is only getting bigger.

How much solar power does Spain have in 2023?

In 2023,installed solar photovoltaic power increased by 28%,bringing an additional 5,594 MWto the Spanish generation pool,the highest figure since records began. As a result,this technology now has 25,549 MW in service,representing 20.3% of the total Spanish energy generation pool.

Is Spain a leader in concentrated solar power?

As a legacy from Spain's earlier development of solar power, the country remains a world leaderin concentrated solar power, accounting for almost a third of solar power installed capacity in the country, a much higher ratio than that for other countries as of 2017.

Is solar energy a renewable resource in Spain?

Although wind is currently the most used renewable resource in the Mediterranean country, solar energy is growing at a very fast pace. In fact, the solar capacity installed has more than quintupled in the last five years. In 2023, Spain was the sixth country worldwide in terms of new capacity additions.
