Igniting sustainability - St. Kitts and Nevis advances with energy storage system. In a significant stride towards achieving its goal of becoming a Sustainable Island State, St. Kitts and Nevis took a monumental step with the activation of a cutting-edge sustainable energy storage system earlier this year.

There are high power losses of 20% on Nevis and 17% on St Kitts suggesting maintenance problems. St Kitts has installed capacity of 43 mW and Nevis 13.4 mW but government has plans for a further 70 mW. The airport has a 1 mW solar farm and the government estimate a potential 16mW of solar power at a rate of 5 kWhrs per m2 over the whole island.
