The storage system will be used to help meet the power demand when the solar PV is not generating. It also will improve the grid stability and serve as a backup to the remaining diesel generators. The \$70 million project in the hands of the state-owned St. Kitts Electric Company (SKELEC) has been under development for almost two years.
