Starting a company in Kuwait requires understanding the tax system in the country. Kuwait follows a territorial tax system, which means that companies are only taxed on income generated within Kuwait's borders.

The manager must be Kuwaiti or from GCC countries. 2- Capital certificate for joint ventures and limited partnerships; the capital of the limited liability company is reserved during the establishment period. Visit the Department of Partnerships of the Ministry of Commerce and Industry, block 2, ground floor, and submit the required documents.

Can foreigners start a business in Kuwait?

According to Kuwait Direct Investment Promotion Authority (KDIPA), non-Kuwaiti nationals can establish a business in Kuwait. However, for the company formation, foreigners need a local Kuwaiti partner or GCC national partner, owning at least 51 percent of any business share.
