What types of warranties cover solar panels?

There are two basic types of warranties that cover solar panels. A product warrantyprotects you from defects in a solar panel stemming from material quality or manufacturing errors. This is also referred to as an equipment or materials warranty

Do solar panels need a warranty?

With no moving parts, solar panels may never need maintenance or repairs for the entire time you own them, which allows manufacturers and installers to confidently offer long warranties. There are three primary warranties for your solar system: performance warranties, equipment warranties, and workmanship warranties.

What is a performance warranty on a solar panel?

A performance warranty guarantees a maximum level of degradation- typically between .25% and .75% - per year so that in 25 years the panel will still have 80-90% of the power output it did in its first year. Performance warranties are important for sizing solar systems to maintain 100% offset for 25 years.

Are solar panel warranties transferable in a home sale?

In most cases, solar panel warranties are transferable to the new owner in a home sale. However, some warranties are restricted to the original owner, so it is crucial to clarify this point with the manufacturer and installer offering the warranty.

How long does a solar panel warranty last?

Most solar panel warranties differentiate between: Workmanship warranty: Covers flaws and defects for 5-10 years. Understanding these differences allows you to identify the terms relevant to your system issues. If you've noticed panel damage or low output, it's also essential to act fast while still under warranty.

How do I Activate my solar panel warranty?
