Is Myanmar a good place to invest in solar power?

According to a study on solar resources and solar PV potential in Myanmar conducted by the World Bank,most of the population (75%-85%) lives within a 25-50 km radius of HV power lines,making it a promising location for medium- and large-scale solar projects. In 2017,peak demand reached ~3000 MW.

Why is solar power important in Myanmar?

Myanmar State Counsellor Aung San Suu Kyi praised solar power for its low maintenance costs, reduced emission levels and contribution to the nation's technological development during the Minbu Solar Power Plant's opening ceremony.

What is the peak demand for energy in Myanmar?

In a report published last month titled 'Myanmar Economic Monitor: Building Reform Momentum',the World Bank predicted that peak demand is expected to reach 8.6 GWby 2025 and 12.6 GW by 2030, which is a significant increase from current levels.

What is ASEAN's largest solar power plant?

Constructed on over 836 acres of land,an area equivalent to almost 530 football fields,the Minbu Solar Power Plantwill be ASEAN's largest solar power plant according to Thailand's META Corporation - the project's contractor and developer.
