Where is Sao Tome & Principe located?

Sao Tome and Principe, country of Central Africa, located on the Equator in the Gulf of Guinea. It consists of two main islands--Sao Tome and Principe--and several rocky islets. What is Sao Tome & Principe known for?

Sao Tome and Principe, once a leading cocoa producer, consists of two islands of volcanic origin and a number of smaller islets lying off the coast of Africa. From the late 1400s Portugal began settling convicts on Sao Tome and establishing sugar plantations with the help of slaves from the mainland.

When did Sao Tome and Principe become independent?

The colony's aspirations for independence were recognised after the 1974 coup in Portugal and at first the Movement for the Liberation of Sao Tome and Principe was the country's sole political party. However, the 1990 constitution created a multi-party democracy. The island of Principe assumed autonomy in 1995.

Who live in Sao Tome & Principe?

Sao Tome and Principe A market on São Tomé island,Sao Tome and Principe. The population consists mainly of Forros(from forro,Portuguese for "free man"),descendants of immigrant Europeans and enslaved Africans. Another group,the Angolares,descended from formerly enslaved Angolans who were shipwrecked on São Tomé about 1540.

Hugo Menezes, director general of tourism for Sao Tome and Principe, tells CNN Travel that just 7,900 people visited in 2010. The country's aim is to increase visitor numbers by 10% each year, he adds, and ensure tourism becomes a prominent economic pillar. Despite its enviable natural beauty, Sao Tome and Principe remains a developing nation.

When did Sao Tome become a country?

Some key dates in Sao Tome's history: Since independence in 1975,São Tomé and Príncipe has been one of Africa's most stable and democratic countries 1493 - First successful settlement of São Tomé by Portugal's Álvaro Caminha - the islands were uninhabited before the arrivbal of teh Portuguese. 1500 - Príncipe settled.
