How much does electricity cost in Timor-Leste?

The cost of electricity in Timor-Leste for commercial and industrial consumers is high compared to ASEAN countries. For instance,in Indonesia industrial electricity tariffs are 0.11 USD/kWh,compared to 0.24 USD/kWhin Timor-Leste.

Is Timor-Leste a good country for solar energy?

Timor-Leste has a high-quality solar resource. The global horizontal irradiance in Dili is higher than on the east coast of Australia, where the solar market is mature and installation costs are higher. Why did Timor-Leste lose electricity?

Most of the energy infrastructure that existed when Timor-Leste was part of Indonesia was destroyed during the violent outbreaks of 1999. At the time of independence in 2002, electricity access was estimated to be just 24 % of the population .

What does a solar technician do in Timor-Leste?

Technicians in Timor-Leste have experience in small-scale, off-grid solar energy systems. Commercial or industrial scale installations are more complex and appropriate technical capacity is scarce.

Timor-Leste is a nation defined still by its 1975-99 struggle for independence, first from Portugal and then from Indonesia. Since regaining formal independence in 2002 after a three-year United Nations mission, Asia's youngest country has navigated the ups and downs of post-conflict nation-building.
