What is vines battery manufacturing factory?

The VinES Battery Manufacturing Factory will provide Lithium batteries for VinFast's electric cars and buses. In Phase One, the factory will scale 8 hectares, funded by a total investment of more than VND 4,000 billion.

How many GWh of battery cells will vines produce a year?

It's expected to produce 5 GWhof battery cells annually. VinES Energy Solutions Joint Stock Company (VinES), a member of VinGroup, and Gotion High-tech, officially broke ground at the joint venture battery factory in Vietnam. This new plant will be crucial to support VinGroup's VinFast ambition to produce and sell electric cars globally at scale.

When will the first vines battery factory start operation?

The factory is expected to start operation in the first quarter of 2024. Last December, Vingroup already began construction of the first VinES battery factory, which is backed by VND4 trillion (\$173.9 million) in capital and developed on eight hectares in its initial phase.

Where are VinFast EV batteries made?

"Located next to the VinES battery pack manufacturing in the Vung Ang Economic Zone, this new factory will complete the closed loop production of LFP Batteries in Vietnam, thereby improving localization for VinFast's EVs and optimizing production efficiency," he said.
